風險披露聲明 Risk Disclosure Statement

本風險披露聲明並非盡列,可能不時以其他風險披露修訂或補充。This following risk disclosure statement is not exhaustive and may be amended or supplemented by additional risk disclosures from time to time.

- (1) 客戶確認並承擔因為於互聯網交易選擇不收取"執行交易"的通知而引致的相關風險。The Client acknowledges and bears the risks associated with opting out from receiving prompt notification on internet trade execution.
- (2) 於互聯網交易選擇不收取"執行交易"的通知,客戶可能未能盡早了解其交易帳戶的交易狀況。By opting out from receiving prompt notification on internet trade execution, the Client may not be able to understand the trading status of Client's trading accounts as early as possible.
- (3) 沒有即時通知,客戶可能未能及時知道、發現及/或停止所有潛在未經授權交易或網上交易帳戶的黑客入侵或異常活動。此舉可能導致客戶未能採取措施降低或減輕與網上交易相關的潛在風險予以保護客戶的網上交易帳戶。Without prompt notification, the Client may fail to know, detect and/or stop all potential unauthorized transactions; hacking activity or abnormal activity of Client's trading accounts in a timely manner. This may result in the Client failing to take measures to reduce or mitigate potential risks associated with internet trading and thus unable to protect internet trading account of the Client.
- (4) 客戶將承受一切引致黑客入侵風險和互聯網交易風險增加或其他原因,可能會導致損失或損害的責任。The increase in hacking risks, internet trading risks or otherwise may result in losses or damages of the Client who will solely and wholly be responsible for such losses and damages.
- (5) 如客戶因於互聯網交易選擇不收取"執行交易"的通知而有所損失或損害,交銀國際證券有限公司不會就此而負上任何責任。BOCOM International Securities Limited shall not be responsible for any losses or damages the Client may suffer for the risks associated with opting out from receiving prompt notification on internet trade execution.
