

本公司及其香港證券登記處所持有關證券持有人的個人資料將會保密,但本公司及其香港證券登記處可以在為達到上述任何目的之必要情況下,向下列任何人士披露、取得或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理人,例如財務顧問、 收款銀行和海外股份過戶登記總處;
- (如證券申請人要求將證券存於中央結算系統)香港結算或香港結算代理人, 彼等將會就中央結算系統的運作使用有關個人資料;
- 向本公司或香港證券登記處提供與其各 自業務營運有關的行政、電訊、電腦、 付款或其他服務的任何代理人、承包商 或第三方服務供應商;
- 香港聯交所、證監會及任何其他法定監 管機關或政府部門或遵照其他法例、規 則或法規;及
- 證券持有人與其進行或擬進行交易的 任何人士或機構,例如彼等的銀行、律 師、會計師或股票經紀等。

4. 保留個人資料
